- 1) 1:00 PM CALL TO ORDER, PLEDGE OF ALLEGIANCE, AND PRAYER
- 2) 1:00 PM DISCUSS THE LAW ENFORCEMENT CONTRACT BETWEEN CASSIA COUNTY AND THE CITY OF BURLEY
 - a) Chairman Crane asked Larsen to read an email he received at 10:31 p.m. Tuesday, August 6, 2013, from City of Burley Administrator, Mark Mitton.
 - b) Mitton indicated that the City Council voted to fund the law enforcement agreement for FY2014 at \$1,450,000.
 - c) A prepared press release was read by Commissioner Kunau announcing the non-renewal of the law enforcement agreement effectively terminating on the last day of the contract, September 30, 2013, as per item 7.2 in the current contractual agreement.
 - d) Chairman Crane expressed regret that there had not been an agreement to fund the agreement for the amount that had been discussed in negotiations between Commissioner Paul Christensen and City of Burley Councilman Randy Hawkins representing both entities.
 - e) Chairman Crane further explained that we had fulfilled the request of Councilman Hawkins to furnish the costs to the County for fulfilling the contractual obligations to the City of Burley.
