

## CHAPTER 1

**CITY OF ROCKS NATIONAL RESERVE**

## SECTION:

 7-1-4: Penalty

7-1-1: **APPLICABILITY:** The following prohibitions on the operations of certain mechanical and audio devices shall be applicable within the boundaries of the City of Rocks national reserve located within Cassia County, Idaho, and more particularly described as follows:

Township 15 South Range 23 East of the Boise Meridian  
 Sections: 13, 23, 24, 25, 26, 35, 36  
 Township 16 South Range 23 East of the Boise Meridian  
 Sections: 1, 2, 11, 12, 13, 14, 23, 24  
 Township 15 South Range 24 East of the Boise Meridian  
 Section 19 except for the North  $\frac{1}{2}$  , of the N.E.  $\frac{1}{4}$  ,  
 Section 20, the South  $\frac{1}{2}$  , of the South  $\frac{1}{2}$  plus the N.W.  $\frac{1}{4}$  , of the S.W.  
 $\frac{1}{4}$ .  
 Sections: 29, 30, 31, 32  
 Township 16 South Range 24 East of the Boise Meridian  
 Sections: 18, 19, 6 and W  $\frac{1}{2}$  , of Section 7  
 All in Cassia County, Idaho

The restrictions imposed by this chapter shall be applicable upon all nondeveloped public and private lands within the aforescribed area of the City of Rocks national reserve. (Ord. 91-10-1, 10-15-1991)

7-1-2: **ENGINES AND MOTORS:** It shall be unlawful and a misdemeanor for any person to operate any type of portable motor, engine or device powered by a portable motor or engine, whether driven by gasoline or other fossil fuels or by electrical or battery power, without the written permission

of the managing agency of the land or the private landowner owning the land upon which such motor or engine or device is operated. This prohibition shall include, but not be limited to, the use of motor driven portable generators, rock drills, and chain saws. This restriction shall not apply to motorized vehicles. (Ord. 91-10-1, 10-15-1991)

7-1-3:           **AUDIO DEVICES:** It shall be unlawful and a misdemeanor for any person upon lands located within the City of Rocks national reserve to operate a motor vehicle, motorized toy, or an audio device, such as a radio, tape deck, television set, or musical instrument, in a manner that makes noise which is unreasonable, considering the nature and purpose of the actor's conduct, location, time of day or night, purpose for which the area was established, impact on park users, impact upon wildlife, and other factors that would govern the conduct of a reasonably prudent person under the circumstances. 7-1-4:           **PENALTY:** Violations of this chapter shall be a misdemeanor and shall be punishable as set forth in section 1-4-1 of this code. (Ord. 91-10-1, 10-15-1991; amd. 2003 Code)
